

TRAINING AGREEMENT OF IMPLEMENTATION

Between

Ministry of Justice of Timor-Leste

And

Yogya Executive School "YES" Yogyakarta – Indonesia

For

Training on Information Technology, Administration and Human Resources Development

On this day, Thursday, The Twentysixth May Two Thousand Sixteen, (26 - May - 2016) in Yogyakarta, Indonesia, the parties signed below:

*In this act for and on behalf of YOGYA EXECUTIVE SCHOOL "YES" INDONESIA hereinafter referred to as the **Second Party**.*

An agreement between Yogya Executive School Yogyakarta-Indonesia and The Ministry of Justice of Timor-Leste, collectively referred to herein as the Parties are entered into. Pursuant to the prevailing laws and regulation in Indonesia and Timor-Leste, as well as the procedures and policy of the both Government Indonesia and Timor-Leste concerning International cooperation.

Article 1

Purpose and Objective

1. The purpose of this agreement is to seek to prescribe the necessary matters related to providing training to Ministry of Justice of Timor-Leste staffs in the areas of Information Technology, Administration and Human Resources Development.
2. The objective of this agreement is to increase the human resources capacity in the Ministry of justice of Timor-Leste.

Article 2

Definition

This agreement will apply to :

1. Participants shall mean the staffs given by Ministry of Justice of Timor-Leste.
2. Participants shall mean any staffs from Ministry of Justice of Timor-Leste who are selected and accepted to attend this training programme for short-term period at Yogya Executive School "YES" Yogyakarta - Indonesia.

Article 3

Eligible participants

This training programme will be limited to the Ministry of Justice of Timor-Leste staffs, who are selected and accepted to attend short training on Information Technology, Administration and Human Resources Development.

Article 4

Number of Staffs

The number of the staffs of the Ministry of Justice of Timor-Leste who will participate in the short training on Information Technology, Administration and Human Resources Development at Yogya Executive School "YES" Yogyakarta - Indonesia is approximately 10 to 20 people.

Article 5

Obligation of the Ministry of Justice of Timor-Leste

1. The Ministry of Justice of Timor-Leste is send 10 to 20 staffs to attend each step to follow the training programm at Yogya Executive School "YES" Yogyakarta - Indonesia.
2. The Ministry of Justice Timor-Leste is obliged to pay the training cost for each step.

Article 6

Obligation of Yogya Executive School "YES" Yogyakarta Indonesia

1. Yogya Executive School "YES" Yogyakarta - Indonesia, is obliged to conduct the training for Ministry of Justice of Timor-Leste staffs.
2. Yogya Executive School "YES" Yogyakarta - Indonesia is obliged to assign qualified experts and lectures to assists in the implementation of activities under this agreement.
3. Yogya Executive School "YES" Yogyakarta - Indonesia is obliged to paid other expenses relations with the training, accommodation and tour packets (field trips) for training participants.

Article 7

Training Arrangements

The Ministry of Justice of Timor-Leste and the Yogya Executive School "YES" Yogyakarta- Indonesia agree as follows:

1. The goals, topics and materials for the training on Information Technology, Administration and Human Resources Development or other types of training will be as agreed to prior to the start of the course programme and in line with the Minister of Justice staffs' needs. Course subjects shall be designed and conducted by lectures and tutors at the Yogya Executive School Yogyakarta.- Indonesia As well as the tours packets (field trips)
2. Yogya Executive School "YES" Yogyakarta - Indonesia, agrees to provide six hours a day (**from Monday to Friday, at 08:00 to 15:00**). **All courses will take place on** Yogya Executive School "YES" Yogyakarta - Indonesia.

Article 8

Financial Arrangements

1. Fees

Ministry of Justice of Timor-Leste agrees to pay Yogya Executive School "YES" Yogyakarta – Indonesia **in the total amount of USD in annex 1.**

2. Invoicing and Procedure of Payment

Yogya Executive School "YES" Yogyakarta – Indonesia shall invoice the Ministry of Justice of Timor-Leste the total cost under the agreement, and the Ministry of Justice of Timor-Leste shall make payment within thirty (30) days of receipt of an invoice from Yogya Executive School "YES" Yogyakarta – Indonesia . The payment shall be made in US Dollars to the following banking details;

Neither of the parties in this agreement will be held responsible for any expenses, losses, damages, cost, claims suits and proceeding sustained or incurred as a direct or indirect result of the participants that it accept as part of the agreement Authorized representatives of Yogya Executive School "YES" Yogyakarta – Indonesia and the Ministry of The Justice of Timor-Leste shall, given two original agreements of implementation documents. Each party shall hold one original signed document, with both document being equally authentic.

Article 11


OTHER TERM


