This Addendum is made and signed in Yogyakarta on August 8, 2016 by and between

 DR. HENRIQUE DE OLIVEIRA XIMENES, MM. QIA. General Director of Justice of The Democratic Republic of Timor-Leste, located on Avenida 20 de Maio, Colmera Number 47 th, Dili. Timor-Leste, hereinafter referred to as the FIRST PARTY;

and

 IR. IRMAN SUAJI, Director of Smile Group Yogyakarta, located in Jl. Prof. Dr. Sardjito 24 Yogyakarta Indonesia, hereinafter referred to as the SECOND PARTY

The FIRST and SECOND PARTY together hereinafter referred to as the "**Parties**". The Parties first explain some things as follows:

- Whereas, the FIRST and SECOND PARTY has previously been agreed and signed an agreement dated May 26, 2016 in Yogyakarta Indonesia, for the training of human resources with materials; Management, Administration and Information Technology program, particularly in Digital Module, E-DMS, E-Procurement and Logistics Management, Financial Management or other types of training.
- Whereas, the participants of training are staffs from the Ministries of Justice of Timor Leste which has been selected for training at the Smile Group Yogyakarta Indonesia.
- 3. FIRST PARTY is obliged to pay a training fee in accordance with the invoice and the SECOND PARTY obliged to provide instructors, training facilities and accommodation in accordance with the agreement.

According the above description, THE PARTIES agreed to make the Addendum to the Agreement with terms and conditions as follows:

# Article 4 Number of Staffs

The number of the staffs of the Ministry of Justice - Timor-Leste who will participate in the short training in Management, Administration and Technology Information or other types of training at the Smile Group of Yogyakarta is approximately **10 to 15 people**.

#### **Changed into:**

The number of the staffs of the Ministry of Justice - Timor-Leste who will participate in the short training in Management, EDMS (electronic document management system), Administration and Technology Information or other types of training at the Smile Group of Yogyakarta is a total of **31 participants**.

- 2. An additional 20 (twenty) participants who will participate in the next training schedule.
- Details of the number of participants for each departure to Smile Group Yogyakarta, the cost of training, training schedule and training materials to be agreed by both PARTIES
- 4. This Addendum is valid from the moment of its signing by the PARTIES.
- 5. Other things that have been stipulated in the agreement, and there are no changes in this Addendum shall remain valid and binding to the Parties.
